For good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the undersigned Photographer ("Photographer") or Videographer ("Videographer") agrees as follows:

Submission of Photographs/Videos. **Photographer/Videographer** is hereby submitting to **Latest Hair Magazine**, its licenses, successors and assigns (collectively "Publisher"), the photographs included in the attached submitter package, which is incorporated by reference herein (collectively "the Photographs" or "the videos"), for use by Publisher on the terms set forth below.

(h) All necessary rights, permissions and consents of third parties (such as, by way of example, models, hair stylist, and makeup artists, etc.) who participated in making of the Photographs/Videos in any way have been secured in writing and delivered to Publisher.

Rights of Publishers. Publisher shall have the right but not the obligation to exploit the rights set forth above in its sole and absolute discretion.
