Photographs.

Stylist hereby acknowledges and agrees that Stylist rendered services as a Hair Stylist, Makeup Artist, Wardrobe Stylist, Barber, or other styling services in connection with the photographs described on the attached Photo Information Form, which is incorporated by reference herein (collectively “the Photographs”).

Non-Exclusive License of Rights.

Owner hereby grants to **Latest Hair Magazine** a non-exclusive, worldwide, royalty-free, irrevocable, unlimited, sub-licensable and transferable license to use all of the materials submitted by Owner, including but not limited to:
